Invitation for Bids

1. The Government of Nepal has allocated funds towards the cost of local road bridge program and intends to apply part of the funds to cover eligible payments under the contract for construction of **Chori Nadi RCC Bridge**. Bidding is open to all eligible Nepalese bidders.
2. Office of District Coordination Committee, Kailali invites sealed bids from eligible bidders for the construction of aforementioned bridges under National Competitive Bidding procedures.

4. A complete set of hard copy of Bidding Documents may be purchased from the office District Coordination Committee, Kailali by eligible Bidders on the submission of a written application, attested the copy of company/firm registration certificate, VAT registration all valid for F/Y 072-073 and tax clearance certificate for year 072-073 upon payment of a non-refundable fee of **NRs 5000.00** before **17:00 hrs on or before May 28, 2017 (2074/02/14)**. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned below or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at Office of district Coordination committee, Kailali **at 11:00 hrs on May 16, 2017 (2074/02/02)**.
6. Sealed or electronic bids must be submitted to the office of District Coordination Committee, Kailali by hand/courier or through PPMO website www.bolpatra.gov.np on or before **May 30, 2017 (2074/02/16) on 12:00 hrs**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **May 30, 2017 (2074/02/16) on 13:00 hrs** at the office of District Coordination Committee, Kailali. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the bid validity period.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
